FCCLA and Family Consumer Sciences Study Questions for Regional, State and National Officer Candidates

1. Who is the legal governing board of Family, Career and Community Leaders of America?

The National Board of Directors. The board determines policy, oversees financial affairs, evaluates current programs and assists in long-range planning and organizational management. Members are both appointed and elected.

2. Where is the national headquarters located?

3. Which two organizations endorse Family, Career and Community Leaders of America?

U.S. Department of Education (Office of Vocational and Adult Education) and the American Association of Family and Consumer Sciences (AAFCS)

4. How much are member national dues?

\$9.00 per person

5. What is the FCCLA tagline, and when was it introduced?

“FCCLA: The Ultimate Leadership Experience” was introduced in 2003

6. What are the four national FCCLA regions?

North Atlantic, Southern, Central, Pacific

7. Missouri is located in which region?

Central

8. What is the mission of FCCLA?

To promote personal growth and leadership development through family and consumer sciences education. Focusing on the multiple roles of family member, wage earner and community leader, members develop skills for life through – character development; creative and critical thinking; interpersonal communication; practical knowledge; and career preparation.

10. What are the five basic components of an FCCLA chapter?

Membership, adviser, leadership, meetings and projects

11. Who is eligible to be a member of FCCLA?

Any student who is taking or has taken a family and consumer sciences education course and who pays the appropriate membership dues, or is a part of a middle level or urban chapter affiliation program.

12. What is FCCLA?

Family, Career and Community Leaders of America, a dynamic and effective national student organization that helps young men and women become leaders and address important personal, family, work and societal issues through family and consumer sciences education.

13. What is a co-curricular FCCLA chapter?

A program that integrates FCCLA chapter activities into the classroom family and consumer sciences program of study. Missouri recommends FCCLA be an integral part of the instructional program.

14. What is the planning process?

A simple five-step method to help chapter members and advisors plan individual, group or chapter projects and activities

15. What is a program of work?

Chapter's plans for the year

16. What is youth-centered leadership?

Process through which youth members are responsible for planning, carrying out and evaluating chapter projects and activities

17. What are the eight purposes of FCCLA?

- 1. To provide opportunities for personal development and preparation for adult life.*
- 2. To strengthen the function of the family as the basic unit of society.*
- 3. To encourage democracy through cooperative action in the home and community.*
- 4. To encourage individual and group involvement in helping achieve global cooperation and harmony.*
- 5. To promote greater understanding between youth and adults.*
- 6. To provide opportunities for making decisions and for assuming responsibilities.*
- 7. To prepare for the multiple roles of men and women in today's society.*
- 8. To promote family and consumer sciences and related occupations.*

18. What are the 52 state associations?

The 50 states, Puerto Rico and the Virgin Islands

19. Who is the current executive director of FCCLA?

Sandy Spavone

20. What is the role of a chapter president?

Presides over the class during project selection and planning. Appoints committees or members for specific jobs related to projects. Serves on the chapter executive council, if one exists.

21. What is the role of the chapter vice-president?

Assists the president in overseeing the work of project committees. Fills in when the president is absent.

22. What is the role of the chapter secretary?

Maintains written minutes of the decisions related to projects and activities. Works with president to complete a written Planning Process worksheet to be posted for member review.

23. What is the role of the chapter treasurer?

Collects and records all fundraising monies and dues. Maintains written records and receipts for all funds spent on chapter project(s).

24. What are bylaws?

Bylaws are the rules adopted by an organization for governing its activities.

25. Name the four kinds of membership in FCCLA.

Active, Alumni, Associate and Honorary

26. How many members are needed to form a chapter?

There is no minimum requirement.

27. Can students in private schools be members of FCCLA?

Yes, as long as they meet membership requirements.

28. What are the three methods of voting?

Voice votes, roll call, or ballot

29. What is a Quorum?

Minimum number of members that must be present to conduct the business of the meeting; usually a simple majority unless otherwise specified in the bylaws.

30. How is FCCLA financed?

FCCLA is a nonprofit organization funded primarily by membership dues.

31. What do national dues support?

Teen Times; The Adviser Newsletter; chapter mailings; national program development; chapter resources; leadership training; national promotion of the organization; membership processing and marketing; National Board of Directors and National Executive Council activities; fundraising and seeking corporate sponsors; operating expenses of the national headquarters and staff.

32. What is affiliation?

The process of formally joining FCCLA by paying membership dues.

33. Who is eligible to use the names “Family, Career and Community Leaders of America” and “FCCLA”, as well as the emblem?

Only affiliated (dues paying) members and chapters.

34. What does the FCCLA emblem represent?

The FCCLA emblem represents Family, Career and Community Leaders of America as a dynamic, active organization. The dominant collegiate lettering articulates a focus on education and student leadership. The swooping arch embodies an active organization that moves toward new arenas. The color of the emblem is one of the organizational colors – red.

35. What are the official FCCLA colors and what do they represent?

Red suggests strength, courage and determination – personal qualities leading to happiness through a positive self-image.

White symbolizes sincerity of purpose and integrity of action, qualities that will help individuals build a better tomorrow.

36. What is the FCCLA flower and what does it represent?

The red rose represents the organization because it gives joy through its beauty and fragrance. It symbolizes a desire for beauty in everyday living.

37. What is the FCCLA motto?

A motto is a short expression of an organization's guiding principles – a phrase that is appropriate to or indicates its character. The FCCLA motto is Toward New Horizons.

38. Repeat the creed.

We are the Family, Career and Community Leaders of America.

We face the future with warm courage and high hope.

For we have the clear consciousness of seeking old and precious values.

For we are the builders of home,

Home for America's future,

Homes where living will be the expression of everything that is good and fair,

39. What is the standard FCCLA Opening Ceremony?

President: Gives a rap with the gavel, signaling the officers and members to stand and then begins the meeting by stating, "We are the members of Family, Career and Community Leaders of America. Our mission is to promote personal growth and leadership development through Family and Consumer Sciences Education."

Officers: "Focusing on the multiple roles of family member, wage earner, and community leader, members develop skills for life through character development, creative and critical thinking, interpersonal communication, practical knowledge, and career preparation."

Members: "As we work toward the accomplishment of our goals, we learn cooperation, take responsibility, develop leadership, and give service."

President: "This meeting of the _____ Chapter of Family, Career and Community Leaders of America is now in session. You may be seated." (Raps gavel)

40. What is the standard FCCLA Closing Ceremony?

President: "Members, please stand. FCCLA members, we are challenged to accept the responsibility of making decisions that affect our lives today and the world of tomorrow. Let us repeat our creed."

*Members: "We are the Family, Career and Community Leaders of America.
We face the future with warm courage and high hope.
For we have the clear consciousness of seeking old and precious values.
For we are the builders of home,
Home for America's future,
Homes where living will be the expression of everything that is good and fair,

President: "This meeting of the _____ Chapter of Family, Career and Community Leaders of America is not adjourned." (Raps gavel)

41. Where should the FCCLA emblem be worn?

Wear the emblem over the heart or on a jacket pocket.

42. Where should the pin be worn?

The pin is worn over the heart. Members, advisers, honorary members, Alumni & Associate member and chapter parents may wear the pin.

43. Who is considered one of the most influential leaders in the founding of Future Homemakers of America?

Edna P. Amidon, an educator and promoter of home economics education. She served as the organization's first board chair.

44. Who was the first national adviser?

Dr. Hazel Frost

45. What was the amount of the first dues in 1945?

10 cents

46. When and where was Future Homemakers of America founded?

June 1945 in Chicago, Illinois

47. What is the name of the organization's magazine, and when was it first published?

Teen Times was first published in 1945.

48. The first national convention was held where and when?

July 1948, in Kansas City, MO

49. How many students are involved in FCCLA?

More than 164,000 chapter members in more than 5,300 local chapters. Over nine million youth have been involved in the organization since its founding in 1945.

50. What is the organization's central focus?

The family

51. When did the Future Homemakers of America and the New Homemakers of America merge?

July 1965

52. When were HERO (Home Economics Related Occupations) chapters founded?

1971

53. STAR Events began in what year?

1983

54. When and where was the name of the organization changed to Family, Career and Community Leaders of America?

July 1999; Boston, MA

55. Why did FHA/HERO change its name to FCCLA?

FCCLA reflects our Mission. It emphasizes the leadership qualities that set our members apart from other young people

56. Missouri was chartered as a state association in what year?

April 1946, Missouri is the 29th chartered state association

57. Involvement in FCCLA offers members the opportunity to expand their leadership potential and develop skills for life. What are skills for life?

Planning, goal setting, problem solving, decision making and interpersonal communication – necessary in the home and workplace.

58. Who is the current (2018-2019) National President?

Kennedy Strickler, Virginia

59. Distinguish between comprehensive and occupational members.

Comprehensive members are currently enrolled in or have taken courses in family and consumer sciences (family-focused). Occupational members are currently enrolled or have taken courses toward preparation for a specific family and consumer sciences career (wage-earning).

60. What is an integrated chapter (also called co-curricular or intra-curricular)?

A chapter whose activities are an integral part of FACS classes. Students develop and carry out chapter projects that meet both course standards and FCCLA program requirements.

61. What qualifications are needed to be a chapter adviser?

Must be a certified comprehensive or occupational family and consumer sciences educator.

62. What is the amount of state dues?

\$2.00 per person

63. Who is eligible for Alumni & Associates membership?

Former FCCLA, FHA (Future Homemakers of America), NHA (New Homemakers of America), HERO members, and individuals who share the goals and purposes of Family, Career and Community Leaders of America.

64. By what procedure are all meetings to be conducted?

Parliamentary Procedure, using Robert's Rules of Order

Four (1 print edition and 3 electronic issues)

Students Taking Action with Recognition

"I move...."

Over half of the votes cast; sometimes called simple majority, which is 50 percent plus one (1)

114. What is the purpose of the Missouri Star Chapters program?

To give recognition to those chapters whose membership represents a significant percentage of the entire family and consumer sciences education program enrollment.

115. What are all 9 national programs?

Career Connection, FACTS, Families First, Student Body, Financial Fitness, Community Service, Power of One, and STOP the Violence.

116. Who is eligible to participate in the Missouri Legislative Shadowing Program?

Juniors and Seniors in high school and current State Executive Council members.
